MEMBERSHIP

Membership Year: 2018

Regular Members (herein referred to as members): Any Cowboy Action Shooter may become a member of the Pungo Posse after observing one and or participating in one club cowboy action shooting match. They must be legal residents of the United States of America, eighteen years of age or older, be a member in good standing of the Single Action Shooting Society, (hereinafter SASS), must be able to legally own, purchase and possess firearms in the Commonwealth of Virginia and who subscribe to the purposes of the Pungo Posse as set forth in Article II of the Pungo Posse By-Laws. They will be entitled to all privileges and responsibilities of the Club, including holding elected office. Dues will be \$50.00 per year. Members only pay the Sussex Shooting Sports portion of the regular match fees for the first Cowboy Action match of the month, the Double Action Revolver Matches and the .22 Rimfire Match which is currently \$10.00. This does not include Sussex County Range War. All shooters pay \$15.00 for the second Cowboy Action Match each month.

Spousal/Significant Others Membership : Spousal/Significant Other (must live in same household as regular member) members are regular members in every way except that their annual dues shall be 50% off regular membership dues.

Junior Member: (under 18) Limited Membership. Does not have voting rights. One time membership fee of \$15.00. Membership valid until 18th Birthday. Shoots free(must be accompanied/supervised by a member parent or legal guardian).

Dues Schedule for 2018.

All regular/spouse memberships will be valid until 31 December 2018.

Applications received in November/December 2017 will be valid upon receipt through December 2018 at no additional Fee. New applications received after January 2018: Dues will be 1/12th the annual rate multiplied by the number of months remaining in the year rounded to the nearest whole dollar.
